CANVASSING RETURNS AND DECLARING RESULTS OF THE NOVEMBER 4, 2025 ELECTION ON THE PROPOSITION ADDING THE AREA GENERALLY LOCATED SOUTH OF NUECES COUNTY EMERGENCY SERVICES DISTRICT NO. 1 WHICH IS LOCATED BETWEEN ROBSTOWN AND NUECES COUNTY EMERGENCY SERVICES DISTRICT NO. 4 AND THE AREA LOCATED GENERALLY SOUTH OF NUECES COUNTY EMERGENCY SERVICES DISTRICT NO. 1 AND NORTH OF NUECES COUNTY EMERGENCY SERVICES DISTRICT NO. 3, EXCLUDING THE MUNICIPAL LIMITS OF ROBSTOWN, TO THE NUECES COUNTY EMERGENCY SERVICES DISTRICT NO. 1 AND THE ANNEXATION AREA ASSUMING ITS PROPORTIONATE SHARE OF THE OUTSTANDING DEBTS AND TAXES OF THE NUECES COUNTY EMERGENCY SERVICES DISTRICT NO. 1, IF IT IS ADDED TO THE DISTRICT IN ACCORDANCE WITH HEALTH AND SAFETY CODE § 775.0751.

Commissioner Keith Havelka introduced an Order and made a Motion that the same be adopted. Commissioner Eusebio Torres seconded the Motion for adoption of the Order. The Motion, carrying with it the adoption of the Order, prevailed by the following vote:

Commissioner Danny Tate thereupon announced that the Motion had duly and lawfully carried and that the Order had been duly and lawfully adopted.

The Order thus adopted reads as follows:

CANVASSING RETURNS AND DECLARING RESULTS OF THE NOVEMBER 4, 2025 ELECTION ON THE PROPOSITION ADDING THE AREA GENERALLY LOCATED SOUTH OF NUECES COUNTY EMERGENCY SERVICES DISTRICT NO. 1 WHICH IS LOCATED BETWEEN ROBSTOWN AND NUECES COUNTY EMERGENCY SERVICES DISTRICT NO. 4 AND THE AREA LOCATED GENERALLY SOUTH OF NUECES COUNTY EMERGENCY SERVICES DISTRICT NO. 1 AND NORTH OF NUECES COUNTY EMERGENCY SERVICES DISTRICT NO. 3, EXCLUDING THE MUNICIPAL LIMITS OF ROBSTOWN, TO THE NUECES COUNTY EMERGENCY SERVICES DISTRICT NO. 1 AND THE ANNEXATION AREA ASSUMING ITS PROPORTIONATE SHARE OF THE OUTSTANDING DEBTS AND TAXES OF THE NUECES COUNTY EMERGENCY SERVICES DISTRICT NO. 1, IF IT IS ADDED TO THE DISTRICT IN ACCORDANCE WITH HEALTH AND SAFETY CODE § 775.0751.

WHEREAS, Notice of this Meeting of the Board of Emergency Services Commissioners has been given in the manner and for the time required by law; and

WHEREAS, at an election held on the 4th day of November, 2025, in the District there was submitted to the qualified voters an election in the District on Proposition A for the addition of the area generally located south of Nueces County Emergency Services District No. 1 which is located between Robstown and Nueces County Emergency Services District No. 4 and the area located generally south of Nueces County Emergency Services District No. 1 and north of Nueces County Emergency Services District No. 3, excluding the municipal limits of Robstown, to the Nueces County Emergency Services District No. 1.

WHEREAS, at the election, **1,450** votes were cast in favor of Proposition A, and **696** votes were cast against Proposition A; and

WHEREAS, at an election held on the 4th day of November, 2025, in the District there was submitted to the qualified voters an election in the District on Proposition B for the Annexation Area to assume its proportionate share of the outstanding debts and taxes of the Nueces County Emergency Services District No. 1.

WHEREAS, at the election, **1,484** votes were cast in favor of Proposition B, and **640** votes were cast against Proposition B; and

WHEREAS, Proposition A did receive the **affirmative** vote of the majority votes cast at the election in the District as provided by law, and Proposition B did receive the **affirmative** vote of the majority votes cast at the election in the District as provided by law; and

WHEREAS, at an election held on the 4th day of November, 2025, in the Annexation Area there was submitted to the qualified voters an election on Proposition A for the addition of the area generally located south of Nueces County Emergency Services District No. 1 which is located between Robstown and Nueces County Emergency Services District No. 4 and the area located generally south of Nueces County Emergency Services District No. 1 and north of Nueces County Emergency Services District No. 3, excluding the municipal limits of Robstown, to the Nueces County Emergency Services District No. 1.

WHEREAS, at the election, **160** votes were cast in favor of Proposition A, and **61** votes were cast against Proposition A; and

WHEREAS, at an election held on the 4th day of November, 2025, in the Annexation Area there was submitted to the qualified voters on Proposition B for the Annexation Area to assume its proportionate share of the outstanding debts and taxes of the Nueces County Emergency Services District No. 1.

WHEREAS, at the election, **155** votes were cast in favor of Proposition B, and **67** votes were cast against Proposition B; and

WHEREAS, Proposition A did receive the **affirmative** vote of the majority votes cast at the election in the Annexation Area as provided by law, and Proposition B did receive the **affirmative** vote of the majority votes cast at the election in the Annexation Area as provided by law,

THEREFORE, BE IT ORDERED, ADJUGED AND DECREED BY THE BOARD OF EMERGENCY SERVICES COMMISSIONERS OF NUECES COUNTY EMERGENCY SERVICES DISTRICT NO. 1, as follows:

Section 1: The matters and facts recited in the preamble of this Order are found and determined to be true and correct; Proposition A to the addition of the Annexation Area generally located south of Nueces County Emergency Services District No. 1 which is located between Robstown and Nueces County Emergency Services District No. 4 and the area located generally south of Nueces County Emergency Services District No. 1 and north of Nueces County Emergency Services District No. 3, excluding the municipal limits of Robstown, to the Nueces County Emergency Services District No. 1, **passed** in properly conducted elections by the eligible voters of both the District and the Annexation Area.

Section 2: The matters and facts recited in the preamble of this Order are found and determined to be true and correct; Proposition B for the Annexation Area to assume its proportionate share of the outstanding debts and taxes of the Nueces County Emergency Services District No. 1, **passed** in properly conducted elections by the eligible voters of both the District and the Annexation Area.

Section 3: Proposition A and Proposition B both received the majority of affirmative votes in the District and the Annexation Area, therefore the Annexation Area is added to the territory of Nueces County Emergency Services District No. 1 as provided under Texas Health and Safety Code Section 775.051.
